

Regolamenti dwar il-ħatra ta' Kap Eżekuttiv u Membri tal-Kunsill Nazzjonali tal-Ktieb

1. Il-Kunsill Nazzjonali tal-Ktieb għandu jkun magħmul minn Kap Eżekuttiv u tmien membri eletti minn fost il-Kittieba, Illustraturi u Fotografi affiljati fl-iskemi tal-Jeddijiet tas-Self Pubbliku u Pubblikaturi rreġistrati mal-Malta Reprographic Rights Organisation (MRRO).
2. Il-Kap Eżekuttiv għandu jkun elett mill-Pubblikaturi, Awturi, Illustraturi u Fotografi affiljati kif jidher hawn fuq. Kull nomina għall-Kap Eżekuttiv għandha tkun iffirmata minn Pubblikatur flimkien ma' Kittieb/Illustratur/Fotografu.
3. Ħames membri mill-Kunsill Nazzjonali tal-Ktieb għandhom ikunu eletti minn fost il-Kittieba/Illustraturi/Fotografi u kull nomina għandha tīgi ffir-mata minn żewġ membri affiljati fl-Iskema tal-Jeddijiet tas-Self Pubbliku li jkunu Kittieba, Illustraturi jew Fotografi.
4. It-tliet membri l-oħra li jiffurmaw il-Kunsill Nazzjonali tal-Ktieb għandhom ikunu magħżula bħala rappreżentanti b'dan il-mod: wieħed min-naħha tal-Gvern; ieħor minn fost il-Pubblikaturi u ieħor minn fost l-Illustraturi u l-Fotografi.
5. Finalment is-Segretarju għandu jkun magħżul mill-Kap Eżekuttiv u approvat mill-Membri tal-Kunsill eletti.
6. Wara li tkun saret is-sejħa għall-elezzjoni ta' Kap Eżekuttiv u Membri tal-Kunsill, għandhom jibdew jintlaqgħu n-nomini skont kif spjegat f'para. 2 u 3 għal matul perjodu ta' tletin (30) jum mid-data tal-pubblikazzjoni tas-sejħa. Wara għandu jibda l-proċess tal-ġhadd ta' preferenzi sabiex jiġu identifikati l-persuni magħżula.
7. F'kaz li n-numru ta' nomini ma jaqbiżx in-numru mitlub fil-karigi msem-mija, allura l-elezzjoni ma ssirx u dawk il-persuni innominati jiġu awtomatikament eletti fil-karigi li għalihom ġew innominati.
8. Il-proċess tal-elezzjoni għandu jitmexxa minn Kummissjonarji u Osservaturi indipendenti maħtura.
9. Kull membru li se jinħatar fil-Kunsill sejkollu remunirazzjoni ta' €2,000 fis-sena.

Regulations on the appointment of the Executive Chairperson and Members of the National Book Council

1. The National Book Council shall be composed of an Executive Chairperson and eight members elected from among the Writers, Illustrators and Photographers affiliated with the Public Lending Rights scheme and Publishers registered with the Malta Reprographic Rights Organization (MRRO).
2. The Executive Chairperson shall be elected by the affiliated Publishers, Authors, Illustrators and Photographers as set forth above. Each nomination for an Executive Chairperson must be signed by a Publisher as well as a Writer / Illustrator / Photographer.
3. Five members of the National Book Council shall be elected from among the Writers / Illustrators / Photographers and each nomination shall be signed by two members affiliated with the Public Lending Rights Scheme who are Writers, Illustrators or Photographers.
4. The other three members of the National Book Council shall be chosen representatives as follows: one from the Government; another among Publishers and another among Illustrators and Photographers.
5. Finally, the Secretary shall be chosen by the Executive Chairperson and approved by the elected Members of the Council.
6. Following the call for the election of the Executive Chairperson and Members of the Council, nominations shall begin to be received as described in para. 2 and 3 for a period of thirty (30) days from the date of publication of the call. This shall be followed by the counting of preferences in order to identify the selected persons.
7. In the event that the number of nominations does not exceed the number of required posts, then the election shall not take place and those nominees shall be automatically elected to the posts for which they have been nominated.
8. The election process shall be conducted by appointed independent Commissioners and Observers.
9. Each member appointed to the Council will receive a remuneration of € 2,000 per year.
