Definizzjonijiet

Id-definizzjoni ta' *Traduzzjoni* għal fini ta' kompetizzjoni fil-Premju Nazzjonali tal-Ktieb hija:

interpretazzjoni lingwistika ta' test letterarju b'ġeneru aċċettat u stabbilit universalment, miktub oriġinarjament f'kull ilsien ieħor (li jkun jissejjaħ Lingwa Sors) u maqlub għall-Malti (li jkun jissejjaħ il-Lingwa Mira).

Il-frazi *Interpretazzjoni lingwistika* tfisser hekk:

test miġjub tali mod u manjiera li jzomm bilanċ raġjonevoli bejn il-'fedeltà' lejn l-intenzjoni formalistika u kontenutistika tal-awtur u t-test tradott/adattat li jkun fih preġġi letterarji intrinziċi u aċċettati minnhom infushom.¹

Il-kriterji użati biex jiġu għudikati testi tradotti b'kontenut letterarju

It-testi kollha fil-ġeneri aċċettati - **Proza Fittizja** (fosthom in-novelli), **il-Letteratura mhux Fittizja**, **id-Drama**, u **l-Poezija** - iridu jkunu evalwati skont id-damma ta' kriterji aġġudikattivi hawn taħt. L-applikazzjonijiet ikunu evalwati wara eżaminazzjoni rigoruża kemm tat-Test Sors (u r-relazzjoni tiegħu max-xogħol tradott għall-Malti komplut) u t-Test Mira tradott, skont il-kwalità **tat-traduzzjoni**, b'attenzjoni lejn l-impatt potenzjali tat-Test Sors oriġinali fuq it-Test Mira, u lejn l-esperjenza sfiqa tat-traduttur jew tradutturi.

¹ F'dal-kaz iż-żwieġ bejn il-'fedeltà' u l-'effettività' ikun ideali. Iż-żewġ skejjel tat-teorija tat-traduzzjoni (dik li temmen b'*les belles infideles* u l-oħra li temmen bil-'ħbieb fidili') għandhom il-virtujiet u l-limitazzjonijiet tagħhom. F'dar-rigward huwa ssuġġerit, għalkemm mhux obbligatorja, li t-traduttur jiddikjara mill-bidu (idealment fil-Kelmtejn ta' Qabel) l-intenzjonijiet tiegħu f'dak li għandu x'jaqsam mal-bilanċ bejn il-fedeltà testwali u l-kreattività testwali. Xi haġa oħra li l-awtur irid isemmi fil-Kelmtejn ta' Qabel hija dwar l-irwoli tal-forma u l-funzjoni (jiġifieri x'inhu mistenni mit-test tradott), u l-qarrejja mmirati.

Definitions

The definition of *Translation* in this context for the purpose of competing for the National Book Prize is the following:

a linguistic interpretation of a literary text of universally-accepted literary genres originally written in any language (to be referred to as the Source Language) into Maltese (to be referred to as the Target Language).

The phrase *Linguistic interpretation* is hereby defined as:

a textual rendering where a reasonable balance is kept between ‘faithfulness’ to the original authorial intention in both content and form, and the translated/ interpreted text incorporating intrinsically accepted literary values in its own right.¹

Criteria used in adjudicating translated texts of literary content

The texts in all the accepted genres - **Prose Fiction** (including *short stories*) and **Non-Fiction, Drama and Poetry** - are to be evaluated as per the adjudicating criteria listed below. Applications will be evaluated on the basis of a rigorous examination of both the Source Text (and its relation to the finished translated work in Maltese) and the translated Target Text, based on the **quality of the translation**, with an eye to the potential impact of the original Source Text on the Target Text, and to the pertinent experience of the translator or translators.

¹ In such cases, the wedding of ‘fidelity’ and ‘effectiveness’ is ideal. Both schools of translation theory (the one subscribing to *les belles infideles*, and the other upholding ‘the faithful ones’) have their virtues and limitations. In this respect, it may be advisable, though not obligatory, for the translator to declare upfront (ideally in the Foreword) his intention regarding his balanced allegiance to text-faithfulness and text-creativity. Another authorial intention to be specifically included in the Foreword by the translator should refer to the roles of form and function (i.e. expected outcome of the translated text), and the target reader/s.
